ORDER:

In the reference 3<sup>rd</sup> read above, the Commissioner and Director of School Education has submitted proposal for filling up the vacant posts of Dist. Educational Officer / Dy. Director by promotion. As verified from the proposal it has been observed that certain Deputy Educational Officers who comes under zone of consideration have not put in three years of service as required under rule 8 of AP Educational Service Rules issued in GO Ms. No. 505, Education Department, dated 16.11.1998, for consideration and inclusion of their names in the panel against their respective feeder category for promotion to the post of District Educational Officer for the panel year 2010-11, as on the date of commencement of panel year i.e. 01.09.2010. Further certain officers coming under zone of consideration in the feeder categories of (1) Lecturer, SCERT/ IASE/ CTE; (2) Sr. Lecturer, DIET and (3) Asst. Director have not fulfilled the sub rule 4 (ii) of rule 6 of GO Ms. No. 505, dated 16.11.1998, i.e. to work as Dy. Educational Officer for becoming eligible for promotion to the category of Dist. Educational Officer. But, in view of the administrative exigency, the posts of DEO / Dy. Director have to be filled urgently.

2. Therefore, it has been necessitated to relax the rule 8 of G.O. Ms. No. 505, dated 16.11.1998 i.e. minimum service of three years of service in the Category / Class from which promotion is to be made and also to exempt the sub rule 4 (ii) of rule 6 of GO Ms. No. 505, dated 16.11.1998 i.e. one year service as Deputy Educational Officer for the feeder categories of (1) Lecturer, SCERT/ IASE/ CTE; (2) Sr. Lecturer, DIET and (3) Asst. Director.

3. After careful consideration of the matter under Rule 31 of Andhra Pradesh State and Subordinate Service Rules, 1996, Government hereby relax rule 8 of G.O. Ms. No. 505, dated 16.11.1998 i.e. minimum service of three years of service in the feeder Category for the following officers are likely to come under zone of consideration for promotion to the category of Dist. Educational Officer.
